SECTION 3: HAZARD IDENTIFICATION

Emergency Overview: White, cotton cloth pad presaturated with isopropanol. Liquid is flammable. Liquid will irritate eyes and skin under repeated or prolonged exposure. Breathing high concentrations of product vapor may produce drowsiness and a headache.

Potential Health Effects:

Eyes: Liquid contents of this product are irritating and can cause pain, tearing, reddening and swelling accompanied by a stinging sensation.

Skin: Prolonged contact with liquid contents may cause skin irritation.
