Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses after the first 5 minutes then continue rinsing eye. Call a poison control center or doctor for treatment advice.
Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. Wash contaminated clothing before reuse.
Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
In case of respiratory irritation; move person to fresh air. If person is not breathing call 911 or an ambulance then give artificial respiration preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.
